|          | Curtis Park <i>Only</i> : alcohol can be possessed and/or consumed between the hours of 12:00 p.m. to 12:00 a.m.  |
| 3.       | No one under the age of twenty-one (21) will be allowed to possess or consume.  |
|          | No glass containers allowed in the park.  |
| 5.       | Alcohol is not allowed at any sporting field at any time whether a sporting event is taking place or not.   |
| 6.       | Selling of alcohol is not permitted at any time.  |
| 7.       | All debris and trash will be put in proper receptacles and removed at the conclusions of the event.   |
| 8.       | At no time can any such event be allowed to disturb the peace and quiet of others.  |
|          | No persons will be given a permit more than twice in one calendar year.   |
|          | No permit will be issued at the same time any youth event is being held in the same park.   |
| 11.      | The chief of police or his designee may suspend this permit at any time for violation of any of these restrictions.   |
|          | The City of Caldwell shall not be held responsible for any injury of damage to any person(s) or property involved in the group for which this permit is issued.         |
| 13.      | Littering and/or damage to the property will not be tolerated and that the person obtaining the permit may be held accountable for any reported incidents of this type. |
| 14.      | The person obtaining the permit must be on site at any time the alcohol is being dispensed and will be responsible for the compliance of these restrictions.            |
