PARKING LOT LIGHTING LEVELS: Caldwell City Code 06-07-13: Qualifications of Licensee states "No license shall be issued to any applicant for a new, renewed or transferred license who: (6) Has a bar/tavern/lounge where parking lot lighting levels have not been designed, installed and maintained at a level of at least 'one foot-candle' which is defined as a unit measurement of illuminance on a surface at ground level equal to one lumen per square foot."
