The floor plan shall include all floors occupied by the applicant and any basement or floor level located below.
2. **PLOT PLAN:** Drawn to a scale of not less than one sixteenth inch (1/16") representing one foot (1'). The plot plan shall include the structure being used, parking, fencing, storage or trash enclosure, lighting locations, street entrances, and walkways.
3. **Please submit two separate drawings (on separate sheets of paper) for the floor plan (interior) and the plot plan (exterior). You can choose to submit copies of the drawings you submitted to the State Alcohol Beverage Control licensing office.**
4. **PARKING LOT LIGHTING LEVELS:** Caldwell City Code 06-07-13: Qualifications of Licensee states "No license shall be issued to any applicant for a new, renewed or transferred license who: (6) Has a bar/tavern/lounge where parking lot lighting levels have not been designed, installed and maintained at a level of at least 'one foot-candle' which is defined as a unit measurement of illuminance on a surface at ground level equal to one lumen per square foot."
