Not sure what the exact format would be, but early brainstorming is leaning towards an event focused on inviting community members to visit the airport and see the amazing array of aircraft based here as well as meet the pilots associated with those aircraft. We might make use of the public tie-down and hot-ramp areas and/or maybe aircraft could be pulled out from their own hangars and the visitors could come by the hangars to see the aircraft -- perhaps riding around the hangar area in shuttle vehicles.

As I mentioned, lots of details to sort out including both "If" we should do it at all and, if we do, then "When". Early suggestions are looking toward sometime in September -- probably a Saturday.

If you would like to make a suggestion, please check in with Lisa at the airport office. And if you would like to just participate in whatever it turns into, please still check in with Lisa since she needs to have a good sense of the level of pilot/hangar owner interest before we make a Go/No-go decision and a detailed plan that will likely include closing the airport for the hours of the open house.
