The Engineering Department currently requires a 1-year construction warranty on all infrastructure dedicated to the City, and a 2-year construction warranty on any pressure irrigation infrastructure dedicated to the City. Effective August 12th, the Engineering Department will require a 2-year construction warranty on all public infrastructure dedicated to or constructed for the City. This change has been observed in Ordinance 3623, attached, approved by City Council on August 6th, 2024.

We hope this revision will provide the City with well-constructed, City owned utilities, roadways, and other infrastructure to serve the Citizens of Caldwell.

ORDINANCE NO. 3623

AN ORDINANCE ENACTED BY THE CALDWELL CITY COUNCIL, ADDING CHAPTER 13 ARTICLE 3 SECTION 10 OF CALDWELL CITY CODE, PERTAINING TO TEXT ADDITIONS REGARDING PUBLIC INFRASTRUCTURE; PROVIDING AN EFFECTIVE DATE; PROVIDING FOR SEVERABILITY; AND REPEALING ALL ORDINANCES, RESOLUTIONS, ORDERS AND PARTS THEREOF, IN CONFLICT HEREWITH.

BE IT ORDAINED by the Mayor and Council of the City of Caldwell, County of Canyon, State of Idaho:

Section 1. That Chapter 13, Article 3, Section 10 of the Caldwell City Code is hereby amended to the following:

13-03-10: PUBLIC INFRASTUCTURE


- (1) <u>All public infrastructure shall be constructed within public rights-of-way or easements, meeting all the standards described in Section 9 of this Article, allowing full access to said public infrastructure for maintenance purposes. During and at the completion of construction, all work must be inspected and approved the by Engineering Department and, upon request, dedicated to The City through an Owner's request and City Council approval.</u>
- (2) Upon final approval of construction and dedication, when applicable, and unless otherwise documented through a Dedication Resolution, the Contractor agrees to a two (2) year warranty for that public infrastructure. A duration of less than two (2) years may be permitted if explicitly authorized in writing by the City Engineer.
