Caldwell Streamlines Building Permit Process

Over the past several months, the City of Caldwell has been exploring ways to streamline the building permit and development review processes. These measures will provide improved customer service and expand our capacity and productivity internally.

We surveyed several customers who have worked with the City and mapped our existing processes. The work culminated with a proposed "red carpet" process where a development team will work with customers from start to finish (e.g. roundtable to certificate of occupancy), providing easy contact and problem resolution within the team.

Members of the team represent all development service departments. Each would perform or facilitate elements of the development process pertaining to their department and collaborate with the others to prevent redundant effort, requirements, or

inconsistencies. The team's main goal is to eliminate lost time in order to deliver projects as rapidly as possible.

As this process is implemented, our staff will monitor delivery time and other factors in order to improve service. Implementation will also include technological solutions to hasten and simplify field inspections, customer access, project status, and project tracking.

The "red carpet" proposal was presented to our customers and staff in a February workshop. Comments received during the workshop have been used to modify the proposal in preparation for an April 5th workshop with the City Council. The workshop begins at 6:00 p.m. at the Caldwell Police Station.

Caldwell DBS Takes a Big Step

In a collaborative effort to help expedite the permitting process, the Caldwell Department of Building Safety (DBS) will now be performing plan reviews and inspections of all Fire Sprinkler Systems, Fire Alarm Systems, and Cooking Hood Fire Extinguishing Systems. This is a big step forward in an effort to create a "one-stop shop" with the permitting process.

In the past, Fire Sprinkler Systems were required to go through the State Fire Marshall's office for review. Once the review was complete it would then be sent to the Caldwell Fire Department for a cursory review to

ensure all local requirements were being met. This could, at times, delay the process depending on the work load of each department.

Now, all permits for these systems will only require submittal to the Caldwell Department of Building Safety. This will not only increase efficiency with the process, but as well in the field. The Department of Building Safety is pleased to have the opportunity to improve our service to the public. Caldwell Adopts Pathways & Bike Routes Plan


In January, the Caldwell City Council adopted a Pathways and Bike Routes Master Plan. The Plan sets a course of action to build a network of pathways and bike routes throughout the City and the Area of City Impact. The goal of the Plan is to link our residents to our city parks, public institutions, the Boise River, Lake Lowell, and other areas of commerce.

The Plan designates 19 miles of shared roadways (where bikes and cars can safely share a travel lane), 73 miles of

bicycle lanes on our classified streets, and 36 miles of proposed pathways. The City has established a Pathways and Bike Routes Committee that will make recommendations to the City Council on proposed improvements to our pathways and bike routes system.

A memorial service will be held for Larry at the Caldwell Train Depot on the afternoon of Saturday, May 1st. Everyone is invited.




Caldwell to Host MS4 Permit Workshop

The City of Caldwell was recently issued a MS4 (Municipal Separate Storm Sewer System) permit #IDS-028118 by the EPA. This permit allows the City to discharge stormwater and certain non-stormwater discharges to waters of the United States. To comply with this permit, an ordinance is proposed to clarify to the public what will be allowed and the consequences of discharge from

sources that are not allowed.

A workshop will be held on May 12th from 6:00 p.m. to 7:00 p.m. in the Caldwell Police Station's Community Room on allowed non-stormwater discharges and what the ordinance should look like on the non-allowed discharges.

The month-long campaign is broken down into four focus areas:


Week 1: Energy & Green Building

As a reminder, residential building permits are required for all decks except decks not exceeding 200 square feet in area, that are not more than 30 inches above grade at any point, are not attached to a dwelling and do not serve the exit door required by section R311.4 of the International Residential Code. Helpful Tips for Re-Roofing a House in the Historic District

Roofing contractors bidding on a job in the Steunenberg Residential Historical District need to ask the home owner to provide a copy of their Certificate of Appropriateness (C of A) before a roofing permit can be issued.

A "C of A" is a document granted by the Historic Preservation Commission (HPC) to a homeowner before construction can commence. The HPC generally checks the roofing material for conformity. Architectural shingles are preferred.


Please refer the homeowner to the Planning & Zoning Department if they are in need a "C of A".

Application process for a "C of A":

 Homeowner submits the "C of A" application and a sample of the roofing material to the Planning & Zoning Department.

- Caldwell Planning & Zoning
 Department verifies all required
 information and contacts the HPC
 Chairperson.
- The HPC Chairperson reviews the application and sample material.
 If approved, the "C of A" will be issued immediately.
- Planning & Zoning contacts the homeowner to pick up the "C of A".
- The contractor will provide a copy of the "C of A" with the building permit application.
